The South Carolina Freedom Caucus Was “Formed Through The State Freedom Caucus Network.” “The South Carolina Freedom Caucus is relatively young, formed in April of last year.

- **During Josh Kimbrell’s Unsuccessful 2018 Run For Congress, A Non-Profit Organization With Ties To A Utility Company Spent At Least \$50,000 Helping His Campaign.** In 2018, the Conservative Leadership Alliance (CLA) “spent more than \$50,000 in the South Carolina race last Thursday, according to the FEC. The group spent roughly half that money supporting GOP candidate Josh Kimbrell, while the other half went to oppose Lee Bright, another Republican candidate in the 4th District race.” [OpenSecrets, [06/13/18](#)]
