At The State And Federal Level, North Carolina Republicans Are Siding With Extremists And Out Of State Oil Interests To Ban Responsible Investing And Oppose Clean Energy Developments That Benefit North Carolinians.

Executive Summary

In 2023, The North Carolina House passed H750 (SL 2023-64), which would <u>restrict</u> the North Carolina State Treasurer from considering "environmental or social considerations" for a state investment unless "they present economic risks or opportunities that qualified investment professionals would treat as material economic considerations under generally accepted investment theories."

Outlets like the <u>Carolina Journal</u> have said this amounts to "[prohibiting] the use of environmental, social, and governance (ESG) criteria from being a factor in state investment decisions." <u>Fox Business</u> called it an ESG ban for state investing.

The bill was sponsored by at least eight members of the extreme North Carolina House Freedom Caucus, including original sponsor Rep. Celeste Cairns. The bill and the effort was also publicly supported by right wing groups like <u>Heritage Action</u> and <u>Foundation for</u> <u>Government Accountability</u>. These groups get major funding from out of state billionaires and their networks, including from the Kochs and Leonard Leo's network.

Joining these extremists and out of state interests were North Carolina Reps. Bill Ward, Allen Chesser and Ken Fontenot who each voted *twice* to pass the anti-ESG bill, helping to provide the three-fifths majority necessary to override Governor Roy Cooper's veto.

Meanwhile, at the federal level, the Inflation Reduction Act has unleashed over \$15 Billion in investment in North Carolina's clean energy economy, but ten North Carolina federal officials still voted against the plan, and they've taken nearly \$3.5 million in campaign cash from the oil and gas industry.

• In North Carolina, A Veto Override Requires The Approval Of Three-Fifths Of Members Present And Voting In A Given Chamber. "Except as provided by subsections (2) through (6) of this section, all bills shall be read three times in each house and shall be signed by the presiding officer of each house before being presented to the Governor. If the Governor approves, the Governor shall sign it and it shall become a law; but if not, the Governor shall return it with objections, together with a veto message stating the reasons for such objections, to that house in which it shall have originated, which shall enter the objections and veto message at large on its journal, and proceed to reconsider it. If after such reconsideration three-fifths of the members of that house present and voting shall agree to pass the bill, it shall be sent, together with the objections and veto message, to the other house, by which it shall likewise be reconsidered; and if approved by three-fifths of the members of that house present and voting, it shall become a law notwithstanding the objections of the Governor."
